Statutory Declaration on RTI Act

Our College is a "College of co-education", which is registered under Society Act by the Government of Maharashtra and affiliated to Shivaji University, Kolhapur, Maharashtra. The College has a Governing Body which is approved by the authority appointed by the Government of Maharashtra. It runs as per the rules and regulations framed by the Government from time to time.

The College comes under Grant-in-Aid category. Therefore, the financial transactions are audited by the Government. The College has formulated different statutory bodies in order to maintain discipline in the premises.

All the Committees / Cells of the College are under Statutory Bodies and come under Section 4 (1) (b) of RTI Act 2005.
