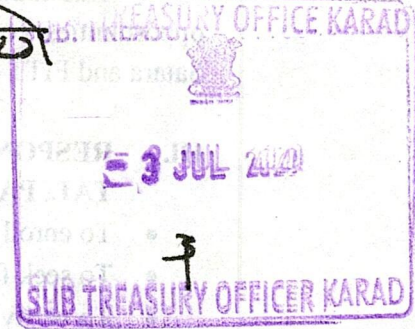

### MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter called as the MOU), this is an agreement between Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist: Satara-415103 and FITT 4U Gym, Talmavale, Tal. Patan, Dist. Satara 415103.

Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara-415103 represented herein by its Prof. (Dr.) S. R. Ghatge, Principal hereinafter referred to as 'First Party' the institution which express, unless excluded by or repugnant to the subject or context shall included its successors-in-office, administrators and assigns.

FITT 4U Gym, Talmavale, Tal. Patan, Dist. Satara 415103, and represented herein the Proprietor, Shri. Vijay Vilas Kurade hereinafter referred to as 'Second Party', which expresses,

unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns.

(First party and Second party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

#### **I. PURPOSE AND SCOPE:**

The purpose of this MoU is to clearly identify the roles and responsibilities of each party as they relate to the implementation of the **Diploma in Yoga and Fitness**.

Both Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and the Industry Partner should ensure that the programme activities are to be conducted in compliance with all applicable UGC laws, rules and regulations.

In particular, this MoU is intended to establish clear guidelines regarding the service work that will be conducted at Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and, if required, at the site of the Industry Partner.

Both parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

#### **II. Background:**

This Industry Partner will be the first for the course to provide service learning and other opportunities coordinated between Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and FITT 4U Gym, Talmavale.

#### **III. RESPONSIBILITIES OF KAKASAHEB CHAVAN COLLEGE, TALMAVALE, TAL. PATAN, DIST. SATARA UNDER THIS MOU:**

- To enroll the students to the said Diploma course.
- To seek funds from UGC and utilize it.
- To verify hours completed by the learners.
- To provide all the infrastructure facilities to the students.
- To prepare the detailed curriculum of the course in consultation with the Industry Partners, Board of Studies (BoS) and Industry Association.
- To appoint the faculty and related staff.
- To carry out all other activities as per UGC rules and guidelines for the course.
- To give the credits and to evaluate the participants.
- To award the Diploma Certificate to the participants.
- Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara will make students available to FITT 4U Gym, Talmavale each year for training as well as job.

#### **IV. RESPONSIBILITIES OF THE SHIVSAMARTH MULTISTATE COOPERATIVE CREDIT SOCIETY LIMITED, TALMAVALE UNDER THIS MOU:**

Industry Partner shall undertake the following activities:

- Provide any necessary training required.
- Provide technical knowledge for the means required to complete each part of the course and related project work.

- To guide for all supplies necessary to complete the project.
- Be in an attendance for any events coordinated through this partnership.
- Provide guidance and supervision to participants.
- To assist for evaluation of participants of Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara.
- To help the participants for the on-site training/placement.

**V. FUNDING:**

This MoU does not include the exchange of funds between the two parties. As per UGC rules the remuneration will be paid to the faculty/staff of the Industry Partner for teaching/practical/project work.

**VI. RECORD RETENTION:**

All records will be retained with Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara from the date of MoU.

**VII. EFFECTIVE DATE AND SIGNATURE:**

This MoU shall be effective upon the signatures of Principal, Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and the Proprietor, FITT 4U Gym, Talmavale authorized officials. This MoU shall be effective from 15<sup>th</sup> July, 2020 to 14<sup>th</sup> July 2025.

Both parties may terminate this MoU upon 30 calendar days notice in writing. In the event of termination, both parties have to discharge their obligations.
