MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter called as the MOU), this is an agreement between Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist: Satara-415103 and Sahyadri Warriors Career Academy, Talmavale, Tal. Patan, Dist. Satara 415103.

Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara-415103 represented herein by its **Dr.A. R. Gade, Principal** hereinafter referred to as '**First Party**' the institution which express, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assigns.

Sahyadri Warriors Career Academy, Talmavale, Tal. Patan, Dist. Satara 415103 and represented herein the Proprietor, Shri. Shivraj Patil here in after referred to as '**Second Party**', which expresses ,unless excluded by or repugnant to the subject or context shall include it's successors-in-office, administrators and assigns.

(First party and Second party are hereinafter jointly referred to as '**Parties**' and individually as '**Party**')

I. PURPOSE AND SCOPE:

The purpose of this MOU is to clearly identify the roles and responsibilities of each party as they relate to the implementation of the **Police and Army Recruitment Training Course**.

Both Kakasaheb Chavan College, Talmavale, Tal.Patan, Dist. Satara and the Industry Partner should ensure that the programme activities are to be conducted in compliance with all applicable UGC laws, rules and regulations.

In particular, this MOUs is intended to establish clear guidelines regarding the service work that will be conducted at Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and, if required, at the site of the Industry Partner.

Both parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

II. Background:

This Industry Partner will be the first for the course to provide service learning and other opportunities coordinated between Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Sahyadri Warriors Career Academy, Talmavale.

III. RESPONSIBILITIES OF KAKASAHEB CHAVAN COLLEGE, TALMAVALE, TAL. PATAN, DIST. SATARA UNDER THIS MOU:

- To enroll the students to the said training course.
- To verify hours completed by the learners.
- To provide all the infrastructure facilities to the students.
- To appoint the faculty and related staff.
- To carry out all other activities as per college rules and guidelines for the course.
- To give the credits and to evaluate the participants.
- To award the Certificate to the participants.
- Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara will make students available to Sahyadri Warriors Career Academy, Talmavale each year for training as well as job.

IV. RESPONSIBILITIES OF THE SAHYADRI WARRIORS CAREER ACADEMY, TALMAVALE, TALMAVALE UNDER THIS MOU:

Industry Partner shall undertake the following activities:

- Provide any necessary training required.
- Provide technical knowledge for the means required to complete each part of the course.

- To guide for all supplies necessary to complete the project.
- Be in an attendance for any events coordinated through this partnership.
- To give the guidance and supervision to participants.
- To assist for evaluation of participants of Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara.
- To help the participants for the on-site training/placement.

V. FUNDING:

This MOU does not include the exchange of funds between the two parties. As per UGC rules the remuneration will be paid to the faculty/staff of the Industry Partner for teaching/practical/project work.

VI. RECORD RETENTION:

All records will be retained with Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara from the date of MOU.

VII. EFFECTIVE DATE AND SIGNATURE:

This MOU shall be effective upon the signatures of Principal, Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and the Proprietor, Sahyadri Warriors Career Academy, Talmavale authorized officials. This MOU shall be effective from 15th July, 2020 to 14th July 2025. Both parties may terminate this MOU upon 30 calendar days notice in writing. In the event of termination, both parties have to discharge their obligations.

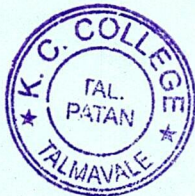
