MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter called as the MOU), is an agreement between Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist: Satara-415103 and Primary Health Centre, Talmavale.





**Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara-415103** represented by its **Principal, Dr. Arun Gade**, hereafter referred as **'first party'**, the institution which express, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assignees.

**Medical Officer, Primary Health Centre, Talmavale** represented hereinafter referred as **'second party'**, the training centre which express, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assignees.  
(First party and Second party are hereinafter jointly referred to as **'Parties'** and individually as **'party'**).

#### **I. PURPOSE AND SCOPE:**

- ❖ The purpose of this MOU is to clearly mention about providing primary health facilities to the students.
- ❖ To explore the areas of cooperation benefitting both the college and Primary Health Centre, Talmavale.

Both, Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Primary Health Centre, Talmavale should ensure that the programme activities are to be conducted in compliance with all applicable UGC laws, rules and regulations.

In particular, this MOU is intended to establish clear guidelines regarding the service work that will be conducted at Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and if required, at the site of the Primary Health Centre, Talmavale.

Both parties intend to cooperate and focus their efforts on cooperation within area of cooperation benefitting both.

#### **II. BACKGROUND:**

This Primary Health Centre, Talmavale will be the first for the course to provide health facilities coordinated between **Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Primary Health Centre, Talmavale.**

#### **III. KAKASAHEB CHAVAN COLLEGE, TALMAVALE, TAL. PATAN, DIST. SATARA RESPONSIBILITIES UNDER THIS MOU:**

- To arrange the social activities and conduct programs which benefit public and society.
- To facilitate regular interaction between student and workforce of institute

#### **IV. Medical Officer, Primary Health Centre, Talmavale RESPONSIBILITIES UNDER THIS MOU:**

- To conduct workshops on Health and diet awareness.
- To provide first-aid facilities to the students, teachers and staff members of the College.



- To conduct various awareness programs on AIDS and other contagious diseases.
- To provide first-aid kits and other medicine.
- To organize HB checking camps.

**V. FUNDING:**

This MOU does not include the exchange of funds between the two parties. As per UGC rules, the remuneration will be paid to the faculty/staff of the Primary Health Centre, Talmavale for teaching/practical/project work.

**VI. RECORD RETENTION:**

All records will be retained with Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara from the date of MOU.

**VII. EFFECTIVE DATE AND SIGNATURE:**

This MOU shall be effective upon the signatures of Principal, Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Medical Officer, Primary Health Centre, Talmavale authorized officials. This MOU shall be effective from 3<sup>rd</sup> March 2022 to 2<sup>nd</sup> March 2027.

Both parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge their obligations. Kakasaheb Chavan College, Talmavale, Tal.Patan, Dist. Satara and Primary Health Centre, Talmavale indicate agreement with this MOU by their signatures.

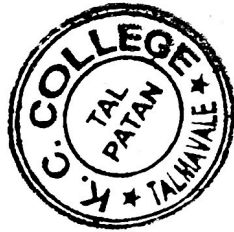
