

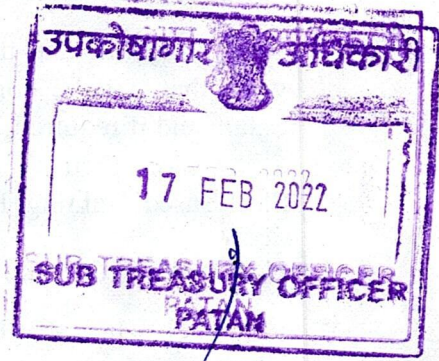

Patan, Dist: Satara-415103 represented by its **Principal, Dr. Arun Gade**, hereafter referred as 'first party', the institution which express, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assignees. **Mrs. Savita Pawar, Aarati Ladies Tailoring Dress Designing, Fashion Designing and Beauty Parlour, Talmavale** represented hereinafter referred as 'second party', the training centre which express, unless excluded by or repugnant to the subject or context shall include its successors-in-office, administrators and assignees.
(First party and Second party are hereinafter jointly referred to as 'Parties' and individually as 'party').

I. PURPOSE AND SCOPE:

- ❖ The purpose of this MOU is to clearly mention about providing coaching for Ladies tailoring, Fashion designing and Beauty Parlour to the girl students of the College.
- ❖ To enhance basic soft skills for entrepreneurship development.

Both, Kakasaheb Chavan College, Talmavale, Tal.Patan, Dist. Satara and Industry Partner should ensure that the programme activities are to be conducted in compliance with all applicable UGC laws, rules and regulations.

In particular, this MOU is intended to establish clear guidelines regarding the service work that will be conducted at Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and if required, at the site of the Industry Partner.

Both parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

II. BACKGROUND:

This Industry Partner will be the first for the course to provide service learning and other opportunities coordinated between **Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Aarati Ladies Tailoring Dress Designing, Fashion Designing and Beauty Parlour, Talmavale**.

III. KAKASAHEB CHAVAN COLLEGE, TALMAVALE, TAL. PATAN, DIST. SATARA RESPONSIBILITIES UNDER THIS MOU:

- To enhance basic soft skills for entrepreneurship development
- To carry out all other activities as per UGC rules and guidelines for the course
- To provide all the infrastructure facilities to the students

IV. AARATI LADIES TAILORING DRESS DESIGNING , FASHION DESIGNING AND BEAUTY PARLOUR , TALMAVALE RESPONSIBILITIES UNDER THIS MOU:

- To provide coaching under Skill Development Programme to the girl students of the college
- To impart training of various courses under "Skill Development Programme" for students of the College by the Institute
- To facilitate regular interaction between students and workforce of the Institute

V. FUNDING:

This MOU does not include the exchange of funds between the two parties. As per UGC rules, the remuneration will be paid to the faculty/staff of the Industry Partner for teaching/practical/project work.

VI. RECORD RETENTION:

All records will be retained with Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara from the date of MOUs.

VII. EFFECTIVE DATE AND SIGNATURE:


