(First party and Second party are hereinafter jointly referred to as 'Parties' and individually as 'party').

Both parties intend to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.

II. Background:

This Industry Partner will be the first for the course to provide service learning and other opportunities coordinated between Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and and M/s Sankalp Shikshan Sanstha, Talmavale

III. KAKASAHEB CHAVAN COLLEGE, TALMAVALE, TAL. PATAN, DIST. SATARA RESPONSIBILITIES UNDER THIS MOU:

- To enhance basic soft skills for entrepreneurship development
- To carry out all other activities as per UGC rules and guidelines for the course
- To provide all the infrastructure facilities to the students

M/S SANKALP SHIKSHAN SANSTHA, TALMAVLE RESPONSIBILITIES UNDER THIS MOU:

- To provide coaching under PRADHANMANTRI SKILL DEVELOPMENT PROGRAMME to the girl students of the college
- To impart training of various courses under "Skill Development Programme" for students of the college by the Institute
- To facilitate regular interaction between students and workforce of the Institute

V. FUNDING:

This MOU does not include the exchange of funds between the two parties. As per UGC rules, the remuneration will be paid to the faculty/staff of the Industry Partner for teaching/practical/project work.

VI. RECORD RETENTION:
