MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereafter called as the MOU), is an agreement between Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist: Satara-415103 and Shikshanmaharshi Bapuji Salunkhe Mahavidyalaya, Karad Tal. Karad Dist. Satara.

Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist: Satara-415103 represented by its Principal, Dr. Arun Gade, hereafter referred as 'first party', the institution which express, unless excluded by or repugnant to the subject or context shall include its successors-inoffice, administrators and assignees. Shikshanmaharshi Bapuji Salunkhe Mahavidyalaya, Karad Tal. Karad Dist. Satara represented by its Incharge Principal, Cap. Dr. Mahesh Gaikwad hereinafter referred as 'second party', for establishing a link between these two organizations to enhance each other's educational, academic and research activities in mutually beneficial manner for the faculty and the students.

I. PURPOSE AND SCOPE:

- ❖ To promote and enhance academic interest through library services.
- To create common digital platforms to share institutional resources.
- * To provide guidance regarding new trends in LIS.
- * To promote research, continuing education, extension activities in both the Colleges.
- ❖ To provide support and training to the library staff.

Both, Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Shikshanmaharshi Bapuji Salunkhe Mahavidyalaya, Karad Tal. Karad Dist. Satara should ensure that the programme activities are to be conducted in compliance with all applicable UGC laws, rules and regulations.

In particular, this MOU is intended to establish clear guidelines regarding the service work that will be conducted at Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and if required, at the site of the Second Party.

Areas of Collaboration:

- To Provide Technical Expertise.
- To provide and access library resources, e-resources and reading material.
- To provide necessary help in organising workshop conferences and seminars.
- To share bibliographic details, books available in the library.
- To create and participate in online Union Catalogue server and future library application.
- To develop library OPAC.

Terms and conditions of ILL (Inter Library Loan) scheme:-

- 1) Books, Journals & CDs will be issued.
- 2) It will be the responsibility of the borrower in regard with the issue and return of the reading material.
- 3) In case of any loss, the borrower will compensate it by paying double amount of the lost reading material.
- 4) The ILLs is free of any cost.
- 5) Revision or modification of the Linkage may be implemented by mutual agreement between both the Principals and the Librarians.
- 6) Either Party may terminate the linkage before expiry by giving notice to other party three months in advance.
- 7) Linkage may be extended if both parties agree and make a fresh agreement.

8) This Linkage will become effective from March 2023 and will be terminated after five years.

V. FUNDING:

This MOU does not include the exchange of funds between the two parties. As per UGC rules, the remuneration will be paid to the faculty/staff of the Partner College for teaching/practical/project work.

VI. RECORD RETENTION:

All records will be retained with Kakasaheb Chavan College. Talmavale, Tal. Patan, Dist. Satara from the date of signing the MOU.

VII. EFFECTIVE DATE AND SIGNATURE:

This MOUs shall be effective upon the signatures of Principal, Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Incharge Principal, Cap. Dr. Mahesh Gaikwad, Shikshanmaharshi Bapuji Salunkhe Mahavidyalaya, Karad authorized officials. This MOU shall be effective from 13th March 2023 to 12th March 2028.

Both parties may terminate this MOU upon three months' notice in writing. In the event of termination, both parties have to discharge their obligations.

Kakasaheb Chavan College, Talmavale, Tal. Patan, Dist. Satara and Shikshanmaharshi Bapuji Salunkhe Mahavidyalaya, Karad indicate agreement with this MOUs by their signatures.
